The residence around the Oakwood treatment Center spoke up to the board regarding the issues they are having with the treatment center. The issues were patient walking away from the center at all times of day and night and wondering through their properties. Some of the patients have come to the residence home to ask for direction or rides. Other are walking down the gravel road without property winter attire. One issue that was brought up was if the patients at the center were court order there. At the original zoning committee the Oakwood Treatment Center representatives stated there would not be any patient that are court ordered, but we are finding out there is individuals there that are court ordered. The Sheriff department is still having issues with the staff regarding patient information. J. Johnson will contact TCPA regarding the issues to have a public meeting to see if the board needs to amend the conditional use permit.

The residences were also concern with the speed of traffic on 48<sup>th</sup> street. The Board requested what time is the worst for speeding traffic, so we can pass this information on to the Sheriff Department.

Deputy Pagel presented the Board with the township's sheriff's report. There were 42 calls last month. The sheriff calls included the following;

- 12 call at Oakwood treatment Center
  - Patient stealing other patient property. He took off into the woods and a neighbor took him to Kwik Trip
- A Suspicious vehicle stopping at mail boxes on 55<sup>th</sup>, no missing items reported
- A young person making prank calls

The Board and residence asked Deputy Pagel question regarding Oakwood Treatment Center and number of calls per month they receive from the center. Deputy Pagel stated the staff at times is not very cooperative with the sheriff department regarding the patients. Other than going to the treatment center the activity was down from the prior month for law enforcement in the township.
