## Haverhill Township Olmsted County, Minnesota Minutes May 15, 2019

Mr. Doug Dose approached the board to discuss Dave and Karen Buchman proposal to build a house on his property that would be serviced by Rochester Public Utilities. The Buchman has three parcels and are wondering what the board thinks. The board recommends the Buchman's to discuss the issue with TCPA, but think to have services provide by Rochester the property might have to be annexed into the city.
