# Haverhill Township Olmsted County, Minnesota Minutes April 21, 2021

## **Public Hearing**

The public hearing is for MN Cold Storage requesting a variance to allow for expansion of a cold storage warehouse. MN Cold Storage is requesting a variance form the set back along Dresser Drive. The Haverhill planning and zoning committee approved the height condition for addition to the warehouse. MN Cold Storage will need a variance to be able to receive a conditional use permit. No one came to a speak for or against the variance.

# Public Hearing closed:

Per J. Johnson and TCPA the road right way must remain intact, and the grading plan must be approved by the township engineers. After some discussion P. Uecker made a motion to approve the variance with TCPA recommendations. D. Felt second the motion; motion Carried.

The township received 3 quotes for rock, Roberson, Milestone, Bruening. The Board will review the quotes and contact the company the board choses to provide rock for Haverhill Township.

## **Sheriff Report:**

Deputy Thompson presented the Board with the township's sheriff's report. Deputy Thompson set up a speed radar sign on Silver Creek Road. The average speed on the road was 38mph. He also stated that there were 78 calls last month. The sheriff calls included the following.
