Minutes

Clerk Report

The minutes of the October meeting were presented for review by J. Mahoney. S. Pollack made a motion to accept the minutes. B Hain second the motion; motion carried

Treasurer Report

J. Barlow gave the treasurer report. The checking account book balance at Bremer Bank is \$82,841.05 and the Money Market account balance is \$838,549.89. The bank balance at Peoples State Bank is \$10,400.21. B. Hain made a motion to accept the Treasurer Report. S. Pollack second the motion; motion carried . J. Johnson motion to pay all bills present. S. Pollack second the motion; motion carried.

Metes & Bounds Subdivision

David Meir approached the board to discuss Gary F & Pamela Oldenburg request to split their 313 acres parcel. The Oldenburg would like to split off 8 acres to sell to Lauri Clements to make her non-farm parcel 10 acres. After some discussion J. Johnson made a motion to approve the metes and bounds with the following conditions

- a. The applicant, Lauri Clement combined the two parcels.
- b. Owners/applicant provide survey showing the proposed metes and bounds subdivision

TCPA

TCPA hired a new employee, Jared Staton. Mr. Staton introduced himself to the Board.

Sheriff Report

Deputy Thompson presented the Board with the township's sheriff's report. He stated that there were 62 calls last month. The sheriff calls included the following.

2. the Staff at Oakridge Treatment Facility stated they will not provide rides to patients who are there as a volunteer commitment if they want to leave, and they will not notify the Sheriff Department if they do leave.
3. The Facility will notify the Sheriff Department if the patient leave and is there under a civil commitment.
4. All patients are in by 10pm.
