### Metes and Bounds

Dave Meir from TCPA approached the board to discuss Gertrude Sehl Trust split. The Gertrude Sehl trust owns two tax parcels totaling 189.7 acres. The trust is requesting two metes and bounds subdivisions to create two buildable non-farm size dwellings. The land is within the urban service plan. The one parcel is steeply sloped and the other is in a floodplain.
